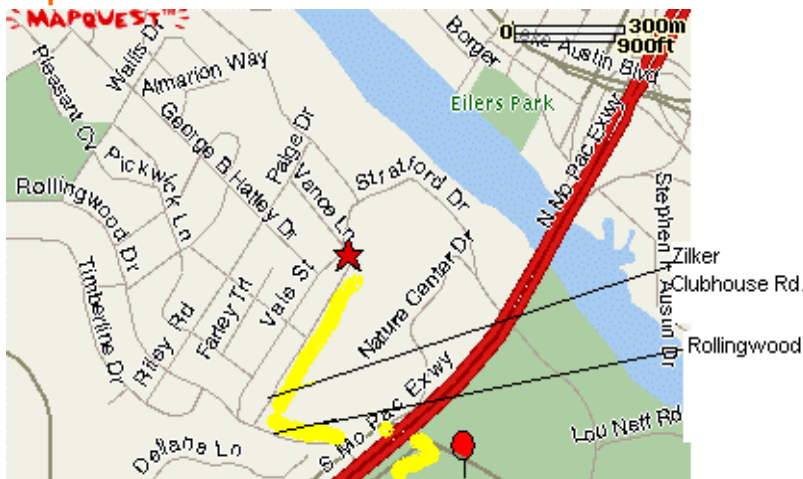

## Map to Zilker Clubhouse



From northbound MoPac: Exit Rollingwood Drive. Turn left at stop-sign after light to go under bridge and get onto Rollingwood Drive.

From southbound MoPac: Exit Rollingwood Drive. Loop under bridge at light. Turn left at stop-sign to go under bridge.

From Rollingwood drive, turn onto Zilker Park Clubhouse Road (road closest to MoPac). Road dead-ends into parking lot for Clubhouse.
